3. Non-member instructors may not give introductory rides to prospective members.
4. The JAC does not provide flight instruction, rather the JAC publishes a list of authorized flight instructors who are permitted to provide instruction to its members.
5. Authorized non-member instructors must receive permission from the JAC Chief Instructor as to what type of instruction they may offer and the JAC aircraft in which they are permitted to instruct.
6. Authorized non-member instructors are not permitted to perform initial aircraft checkouts.
7. Authorized non-member instructors are not permitted to perform JAC annual proficiency checkrides or aircraft currency checkrides unless specifically authorized by the JAC Chief Instructor.
8. Authorized non-member instructors are required to understand and comply with all applicable JAC by-laws and rules.
